CALL TO ORDER

President Greg Higel called the meeting to order at 10:04 a.m. The Pledge of Allegiance was recited. There was a quorum present for the meeting.

INTRODUCTION OF STAFF & GUESTS

President Higel welcomed all those present and asked for introductions.

APPROVE AGENDA

President Higel asked for any changes or additions to the agenda. President Higel asked to add Resolutions under seven (7) and eight (8), and Cleave Simpson added under Election of Officers the reappointment of Ex-Officio members of each Subdistrict. A motion was made by Dwight Martin to approve the agenda as presented. The motion was seconded by Cory Off and unanimously approved.

APPOINT NEW DIRECTOR FROM ALAMOSA COUNTY

President Higel asked for the appoint of the new director from Alamosa County. David Robbins swore in Mike Kruse from Alamosa County.

 Reappointment of Rio Grande Water Conservation District Board of Directors Cory Off and Bill McClure

President Higel asked for the reappointment of Cory Off and Bill McClure. Cleave Simpson stated no action was needed, confirmation was received from Rio Grande County and Saguache County Commissioners for the reappointment to serve as Directors. David Robbins stated they both had already taken the oath.

ELECTION OF OFFICERS

President Higel asked for the election of officers and turned the meeting over to David Robbins. Mr. Robbins opened up the floor for nominations for President currently held by Greg Higel. A motion was made by Cory Off to nominate Greg Higel for President. The motion was seconded by Brian David. Dwight Martin made a motion for nominations to cease. The motion was seconded by Cory Off and unanimously approved. Greg Higel was nominated President by acclamation.

The meeting was turned over to President Higel. President Higel asked for nominations for Vice President currently held by Brian David. A motion was made by Dwight Martin to nominate Brian David for Vice President. The motion was seconded by Cory Off and unanimously approved. Brian David was elected Vice President by acclamation.

President Higel asked for nominations for Secretary/Treasurer currently held by Dwight Martin. Bill McClure asked for clarification on the Secretary/Treasurer position and the responsibilities.

Further discussion was held and Mr. McClure requested a more detailed discussion at the next meeting.

A motion was made by Cory Off to nominate Dwight Martin by acclamation for Secretary/Treasurer. The motion was seconded by Peggy Godfrey and unanimously approved. Dwight Martin was elected Secretary/Treasurer by acclamation.

Cleave Simpson provided the Board with a list of each Subdistrict Board Members and Ex-Officio Members (copy attached). Mr. Simpson asked if everyone was still comfortable with each Ex-Officio. A motion was made by Peggy Godfrey to retain the current Ex-Officio members of Subdistricts No. 1, 2, 3, 4, 5 and 6. The motion was seconded by Cory Off and unanimously approved.

President Higel asked for a motion to approve the consent agenda items:

A motion was made by Cory Off to approve the consent agenda items. The motion was seconded Peggy Godfrey and unanimously approved.

David Robbins read three (3) Resolutions into record (copies attached):

A motion was made by Armando Valdez to accept the Resolution for Carl Worley. Peggy Godfrey seconded the motion and it was unanimously approved.

A motion was made by Armando Valdez to accept the Resolution for Floyd Getz. Dwight Martin seconded the motion and it was unanimously approved.

A motion was made by Peggy Godfrey to accept the Resolution for Ruth Heidi. Dwight Martin seconded the motion and it was unanimously approved.

PUBLIC COMMENT

President Higel asked for Public Comment. There was no public comment.

FINANCIAL REPORT

President Higel asked for the Financial report. Cleave Simpson presented the financial report, he stated Subdistrict's No. 2 and 3 now have a revenue inflow. Bill McClure requested to see all funds including the Subdistricts on the balance sheet. David Robbins stated he and staff will gather the requested information and distribute to the Board in order to have a detailed discussion in the near future. Mr. Simpson also provided the profit loss budget vs actual revenues and expenditures and pointed out a few note worthy items. Mr. Simpson provided an update on the Doppler Radar as well as Diamond Springs monitoring.

A motion was made by Bill McClure to approve the financials. The motion was seconded by Peggy Godfrey and unanimously approved.

MANAGER'S REPORT

President Higel asked for the Manager's report. Cleave Simpson updated the Board on his activities since the last meeting (copy of report attached). Mr. Simpson reported on and presented the following:

- Presented to a variety of stake holders, including several ditch companies, county commissioners, among others.
- Mr. Simpson reported conducting interviews and hiring Tim Carden who is the new HCP Coordinator/ Program Technician.

President Higel thanked Mr. Simpson for his report.

PROGRAM MANAGER'S REPORT

President Higel asked for the Program Manager's report. Amber Pacheco reported Subdistrict No. 2 and 3 filed Annual Replacement Plans with the State Engineer and the court and hope to start making replacements by May 1, 2019. Ms. Pacheco stated Subdistrict No.'s 4, 5 and 6 are working on their Plans of Water Management and are close to completion. Ms. Pacheco stated she continues to meet with municipalities and federal government well owners discussing potential contracts.

President Higel thanked Ms. Pacheco for her report.

DISTRICT ENGINEER'S REPORT

President Higel asked for the District's Engineer report. Allen Davey and Clinton Phillips presented a power point update on the groundwater levels of the confined and unconfined aquifer storages. Mr. Phillips showed the confined aquifer sites and pointed out the model layers and amounts. Mr. Phillips reported being contacted by HRS regarding the modeling wells in the upper Rio Grande area and stated they will move forward with the new monitoring wells.

President Higel thanked Allen Davey and Clinton Phillips for the report.

DISTRICT ATTORNEY'S REPORT-DAVID ROBBINS

President Higel asked for the District Attorney's report. David Robbins recognized Dustin Sharrer from Senator Gardner's for being very helpful to the District. Mr. Robbins reported on another version of the Waters of the United States rule and stated the he has filed comments on behalf of the District. Mr. Robbins stated Judge Swift entered her ruling approving the Rules and Regulations that were adopted by the State Engineer. Mr. Robbins stated as long as there are no challenges to the rules, they will go into effect. Mr. Robbins reported on contract exchanges and the push to reduce water technics, as well as the Law of the Rio Grande conference.

President Higel thanked David Robbins for his report.

KOGOVSEK AND ASSOCIATES-CHRISTINE ARBOGAST

President Higel asked for Kogovsek and Associates report. Christine Arbogast was present and updated the Board on the Colorado Water Congress and the two new delegate members. Ms. Arbogast stated the Colorado Water Congress priority is infrastructure however no solution yet on out how to pay for it. Ms. Arbogast reported on the new Secretary of the Interior, the Farm Bill implementation and the Closed Basin appropriation issues.

President Higel thanked Cleave Simpson for reading the report.

STEALEY II-BECKY BROOKS

President Higel asked for the Stealey II report. Becky Brooks was present and gave an update on the General Assembly and the members. Ms. Brooks reported on the funding for water issues, severance tax, climate change bill as well as the bills associated with water.

President Higel thanked Ms. Brooks for her report.

SENATOR GARDNER'S OFFICE

President Higel asked for Senator Gardner's office report. Dustin Sharrer was present and reported on the Clean Water Act as well as the 2018 Farm Bill. Mr. Sharrer touched on USDA and HEMP as well as the CREP program and stated we should see something soon. Mr. Sharrer stated they are going to try to do another water infrastructure development act bill.

President Higel thanked Mr. Sharrer for her report.

CONGRESSMAN TIPTON'S OFFICE

President Higel asked for Congressman Tipton's office report. Brenda Felmlee reported attending recover meetings with NRCS in connection with the Costilla County burn scar. Ms. Felmlee also stated she has attended some high-water events.

President Higel thanked Ms. Felmlee for her report.

SENATOR BENNET'S OFFICE

President Higel asked for Senator Bennet's Office report. Erin Minks was present and reported Michael Bennet is on the Finance Committee and the AG Committee and was active in getting the Farm Bill to pass. Ms. Minks reminded the Board and audience of the roles Mr. Bennet plays in D.C. on a daily basis. Ms. Minks also reported on the current projects Mr. Bennet is working on like keeping water supplies going in small communities. Ms. Minks also provided an update on CREP signups.

President Higel thanked Ms. Minks for her report.

U.S.B.R. REPORT-CLOSED BASIN OPERATING COMMITTEE UPDATE

President Higel asked for the U.S.B.R./Closed Basin Operating Committee report. Morgan Garcia reported on the activities within the Bureau of Reclamation. Ms. Garcia provided the status of the water salvage operations, storage capacity at San Luis Lakes and the amount of deliveries. Ms. Garcia stated the maintenance crew continues to re-drill and rehab wells as well as maintain equipment and upkeep of the canal. Ms. Garcia also provided an update on the actives in the lab.

George Whitten was present and provided an update on the Closed Basin Operating Committee. Mr. Whitten reported why and where the committee came from and what has been learned.

Rich Roberts provided an update on the day to day operations and the current status of the Closed Basin. Mr. Roberts showed a map of the boundaries of the project and reported how and when the project was constructed as well as how it flows. Mr. Roberts presented some images of the creeks and the Closed Basin to show the changes.

Mr. Higel thanked Ms. Garcia, Mr. Whitten and Mr. Roberts for their reports.

The meeting recessed for lunch at 12:40 p.m. and resumed at 1:45 p.m.

RIO GRANDE NATIONAL FOREST

President Higel asked for the Rio Grande National Forest report. Daryl Kohut introduced himself as the new Hydrologist and stated he would be reporting at future meetings.

Mr. Higel thanked Mr. Kohut for introducing himself.

COLORADO STATE PARKS AND WILDLIFE REPORT

President Higel asked for the Colorado State Parks and Wildlife report. Ryan Unterreiner was present and provided an update on the reservoirs. Mr. Unterreiner stated Trujillo Meadows is filling and will be stocked with fish this year as well as many other reservoirs in the valley. Mr. Unterreiner updated the Board on the dam safety group maintenance projects and reported his agency deadline to notify Water Resources their intentions to comply with ground water rules is approaching and they are working closely with the Subdistricts.

President Higel thanked Mr. Unterreiner for his report

COLORADO STATE FOREST SERVICE

President Higel asked for the Colorado State Forest Service report. Adam Moore provided the Board with the annual Colorado Health of the Forest Report and updated on the insects and diseases in the state. Mr. Moore talked about the beetles and provided the highest location of the bugs. Mr. Moore emphasized protecting our communities and the program CORAP, and he also demonstrated an interactive map.

President Higel thanked Mr. Moore for his report.

GREAT SAND DUNES NATIONAL PARK AND PRESERVE REPORT

President Higel asked for the Great Sand Dunes National Park and Preserve Report. Pam Rice reported the Medano Creek was at about 170% and had reached the parking lot. Ms. Rice stated visitation is down due to being closed most of January, however they are preparing for a very busy season. Ms. Rice reported on the Medano Ranch property acquisition as well as the "dark sky park" designation. Ms. Rice also stated they hope to reintroduce the Rio Grande Cut Throat trout to Sand Creek.

President Higel thanked Ms. Rice for her report.

U.S.G.S REPORT

President Higel asked for the U.S.G.S report. Bob Kimbrough provided a briefing on the U.S.G.S activities in the San Luis Valley and stated he is reporting on behalf of Crystal Brown. Mr. Kimbrough reported on the five program elements, four of which are associated with ground water monitoring and the results from those networks are used by the District Engineer for evaluating and calculating aquifer storage, water level changes and used by consultants for modeling purposes.

President Higel thanked Mr. Kimbrough for his report.

SAN LUIS VALLEY WATER CONSERVANCY DISTRICT REPORT & COLORADO WATER CONSERVATION BOARD REPORT

President Higel asked for the SLV Water Conservancy District report. Heather Dutton was not present however provided the Board with a report via email. (copy attached)

RIO GRANDE HEADWATER RESTORATION PROJECT

President Higel asked for the Rio Grande Headwater Restoration Project report. Emma Ressor reported they were working to finish up a couple of construction projects including the San Luis Valley Canal head gate project, consolidated diversion dam replacement project and preparing for new projects. Ms. Ressor thanked the Colorado Water Conservation Board and the NRCS who helped fund and design some projects. Ms. Ressor also reported on bank stabilization, channel stability, land owner outreach and stream management plan. Ms. Ressor reported they will be teaming up with Headwaters Alliance for their annual fundraiser being held on June 1, 2019.

President Higel thanked Ms. Ressor for her report.

DIVISION ENGINEER'S REPORT

President Higel asked for the Division Engineer's report. Pat McDermott was present and reported on the current water conditions. Mr. McDermott reported the division will soon be interviewing for the new Assistant Division Engineer position and reported hiring a new Deputy Water Commissioner in Saguache Creek. Mr. McDermott stated the division is actively searching for abandoned wells. Mr. McDermott also reported on the conditions at the top of Snow Mesa at Bristol and reported having bi-weekly meetings with David Osborn in connection with the localized flooding threat. Mr. McDermott provided the storage amounts in the reservoirs as well as the forecast for April, May and June. Mr. McDermott also provided an update on the Rules Case and what comes next as well as thanking David Robbins for his role in the case.

President Higel thanked Mr. McDermott for his report.

SALAZAR RIO GRANDE DEL NORTE CENTER

President Higel asked for the Salazar Rio Grande Del Norte Center report. Rio de la Vista was present and reported what the Rio Grande Natural Area is and how it was started. Ms. De La Vista reported on the projects they are focusing on and the partnerships of the initiative. Ms. De La Vista showed a Power Point map of the conservation lands/public lands, the Cultural/Historical Preservation and presented a video on the McIntire Ranch & Mansion as well as the possibilities for restoration. Ms. De La Vista updated the Board on the Interpretation, Signage and Site Developments.

President Higel thanked Ms. De la Vista for her report.

EDUCATION REPORT- BETHANY HOWELL

President Higel asked for the Education report. Bethany Howell reported on the education programs coming up this summer including a rafting trip, water fest, the River Trailer and youth conservation camps. Ms. Howell also reported on a kayaking trip on the Lobato which will allow the students to explore and learn about the watershed for themselves.

President Higel thanked Ms. Howell for her report.

RIO GRANDE INITIATIVE/R.I.G.H.T

President Higel asked for the Rio Grande Headwaters Land Trust/R.I.G.H.T report. Allen Law reported working on three (3) or four (4) conservation easements on the Rio Grande River, one on the Alamosa River as well as a new one in Conejos County. Mr. Law stated they are also working on some up north in Saguache County in the Baca area.

President Higel thanked Mr. Law and Ms. Lopez for the report.

CONSERVATION PROJECT MANAGER FOR COLORADO OPEN LANDS

President Higel asked for the Conservation Project Manager for Colorado Open Lands report. July Lopez reported the Colorado Open Lands has been busy with 2,500 acres of conservation easements in the Culebra basin and hope to close on half of them by the end of the year. Ms. Lopez stated they did an RCPP program with implementations of about \$400,000 of irrigation improvements. Ms. Lopez reported on the conservation easements they are working on currently.

President Higel thanked Ms. Lopez for her report.

OTHER REPORTS-PRESENTATION: ALL THAT INVISIBLE WATER HIDING IN THE SLV

President Higel asked for any other reports. Nicole Langley presented "All that Invisible Water Hiding in the San Luis Valley". Ms. Langley stated she was approached by some individuals and asked for her ideas on how to help the water situation. Ms. Langley's presentation included a Power Point which began with "How can we preserve our AG Economy & Way of Life in the San Luis Valley" as well as the "Systems Thinking Entropic System". Ms. Langley provided the Board with some of the projects and foundations she has been involved with and stated she would like to meet to discuss and explore further. Ms. Langley requested a sponsorship from the Rio Grande Water Conservation District in order to move forward. Cory Off stated he would like to purse the ideas. Armando Valdez requested to see a scope of the work and the Board agreed another meeting or work session would be needed to discuss further. Cleave Simpson stated he would put together a work session to discuss further.

Peggy Godfrey requested a discussion on the Closed Basin presentation. Mr. Simpson stated he would include the discussion at the next work session.

President Higel thanked Nicole Langley for her presentation.

Dear Cleave,

Today I have given you and your Board a 20-minute introduction to the concepts and principles of the FEW Nexus; on funding from the National Science Foundation which has been awarded to CSU to prepare future scientists in that field; and on the prospect for possibly including the San Luis Valley in the current and future benefits of assessment, mitigation and adaptation which are provided by this proven decision support system.

I have had some conversations and three months of email and phone communication with some of Colorado's top scholars and thought leaders in the field, and several of them have indicated a desire to pursue these discussions further. I therefore would like to meet with you to discuss and explore how best to pursue these ideas and potential opportunities.

These are important developments with perhaps some critical benefits for future water managers and planners in our basin, but I understand from you, and also from Rio, that there is currently nobody in the SLV involved in this field or pursuing these ideas. Because of my education and background as a consultant in whole systems design, I propose that RGWCD initiate a six month scoping and investigation project, supporting and expanding my discussions and explorations of the FEW Nexus and giving these ideas the institutional backing and support that our colleagues at CSU and other organizations deserve.

Let's talk about how to pursue these ideas, decide on a way to proceed, and put together a 6-month budget, based on the goals and outcomes you'd like to see. I also suggest that Adams State University might be interested in partnering or collaborating with this initiative in some way, and, if so, I am ready to pursue perhaps creating a graduate or undergraduate curriculum/program, seeking guidance from our NSF-funded scholars at CSU, that is relevant to the challenges we face.

Thanks so much for the opportunity to bring this to you. I look forward to being your liaison on behalf of this Valley, to positively exploit this exciting new opportunity, and to give our basin's stakeholders and decision makers the backing and support we all need in order to make good things happen.

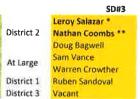

Hello District Board,

I apologize for missing your meeting. It is always enjoyable to hear the updates from the different speakers and to catch up with everyone. I am currently on my way home from a raft trip in the Grand Canyon, which has been a dream of mine for quite some time!

CWCB Report

A great focus of the CWCB in the last 6 months has been working with stakeholders in the Colorado River Basin to develop plans to manage drought. As supply continues to decline, the 7 Colorado River States and Mexico are engaging in tough conversations to plan future water management through Drought Contingency Plans.

In 2019, the CWCB is proposing one new in-stream flow in the Rio Grande Basin on Carnaro Creek from the confluence of the South and Middle Forks of Carnero Creek to the Mogotas Arroyo. The goal of this appropriation is to maintain existing flows in this reach to protect native fish and current stream conditions. The flow would have a 2019 priority date, so it would be junior to all existing water rights and would not impact their diversions. This is the reach the CWCB staff discussed in their presentation to the District's Board in January.

The CWCB continues to provide funding for water projects in the Valley through grants and loans. I thought it would be helpful and interesting to recap all the funding the Valley has obtained from the CWCB in the last year:

Low-interest loans have been approved for the San Luis Valley Irrigation District and Trinchera Irrigation District for reservoir rehabilitation projects. The SLV Canal received a loan to repair their headgates.

Rio Grande Headwaters Land Trust and Colorado Open Lands received grants for conservation easements.

Conejos Water Conservancy District received a grant to update diversion structures.

Trout Unlimited received a grant to mitigate dead trees at Spruce Lakes.

Mineral County Fairgrounds received a grant to improve and pipe their ditch from Willow Creek.

RWEACT received a grant to improve river recreation access.

Sangre de Cristo Asequia Association received a grant to develop education and outreach materials.

Terrace Reservoir Company received a grant to assess the condition of their outlet.

San Luis Valley Water Conservancy District received a grant for a soil moisture probe pilot project.

Subdistrict 1 received a grant to provide telemetry for a portion of the RGWCD monitoring wells.

Rio Grande Headwaters Restoration Project received a grant for the Del Norte Riverfront Project.

Mosca-Hooper Conservation District received a grant to study aquifer recharge zones.

San Luis Valley Water Conservancy District Report

The District continues our regular business of providing augmentation for domestic, municipal, and commercial wells. I anticipate our obligation will be approximately 400 acre-feet in 2019. In 2018, we sold water from storage to Subdistrict #3. If flows from our water rights are significant in 2019, I will work with District staff to make water available for Subdistricts, if needed.

The following request is made, pending budget modification approval from the Colorado Water Conservation Board related to this request.

Mosca-Hooper Conservation District (MHCD) has secured funding from Colorado Water Conservation Board (CWCB) to fund the drilling of 5 monitoring wells, as part of the Targeted Recharge Project (Electrical Resistivity Imaging) the district is deploying in April 2019. The funding level secured for the wells is \$9,800 from CWCB. MHCD has identified a well driller with equipment capable of retrieving cuttings offering good resolution (approximately 6"), to detail where clay lenses, rock, gravel, and sand are located, for \$10,000.

The same driller has equipment capable of drilling the monitoring wells and deploying a Hydraulic Profiling Tool (HPT), which would offer a near-continuous logging of the pressure required to inject a flow of water into the soil as the probe is advanced into the subsurface, which is reported to offer an excellent indicator of formation permeability. This data can be utilized to then calculate an estimate of hydraulic conductivity, and further transmissivity, of the materials surrounding the monitoring wells. The cost of this method of developing the monitoring wells is estimated to be \$13,500.

To permit the wells dug as monitoring wells, the Division of Water Resources requires a \$100 fee per well. There will be five wells developed to monitoring well standards as part of this project, totaling \$500 to permit all wells accordingly.

MHCD requests Rio Grande Water Conservation District fund \$4,200 towards the project (\$500 permitting fees + \$13,500 well drilling with HPT – \$9,800 grant funds already secured from CWCB), to provide the additional data from each of the monitoring wells which the HPT approach offers and so the wells may be permitted as monitoring wells, for future use by RGWCD within its well monitoring network. Deployment of the HPT could be useful for validating further assumptions of transmissivity currently in use within the Rio Grande Decision Support System for groundwater modeling in the unconfined aquifer in the area surrounding the Targeted Recharge Project test site, and the addition of wells to the monitoring network helpful in gaining resolution relative to response rates for water level changes.

OPERATIONS

Water salvage operations continued as recommended by the Project Operating Committee to meet the Rio Grande Compact, mitigation, and Subdistrict #1 depletion obligations.

A total of 477 AF was made to the Alamosa National Wildlife Refuge through CHO1 & CHO2.

A total of 248 AF was delivered to the Blanca Wildlife Habitat Area through CHO3 & CH04.

Delivery to the Rio Grande for the year to date is 2,410 AF.

San Luis Lake did receive inflow from Big Spring Creek in March. The lake elevation rose 0.4' from 7511.6 to 7512.0 ft.

MAINTENANCE BRANCH

The drill crew is currently redrilling SW058. The rehab crew just finished the rehabilitation of SW037A and moved on to SW042A. The maintenance crew is busy working on Salvage Well vault maintenance, lateral line valve maintenance, canal repairs, heavy equipment maintenance and structure gate equipment maintenance.

Rio Grande Water Conservation District Crew

The RGWCD crew continues to assist with salvage well maintenance, rehabilitation and drilling activities. Other work completed includes blading and mowing all canal berms and lateral access roads, removal of aquatic weeds and sediment from the canal and associated structures, repair and maintenance of right-of-way fences, and repair of erosion along the canal berms. RGWCD staff also assisted in maintenance of vehicles and heavy equipment.

Manager's Work

Division Manager continues to work with RGWCD Management Team to schedule work for the RGWCD maintenance crew.

WATER LABORATORY

A total of 306 samples were collected from the Closed Basin Project during the period of January 1, 2019, through March 31, 2019.

Total Dissolved Solids at the Outlet was an average of 305 ppm for the period.

Lab personnel assisted Operations, Maintenance and Admin groups, as well as local agencies, on various projects.
