**Meeting Called to Order**

President Faucette called the meeting to order at 1:31 p.m. A quorum was present. The Pledge of Allegiance was recited.

A motion was made to approve the consent agenda. The motion was seconded and unanimously approved.

**Public Comment**

President Faucette asked for public comment. Stephen Lauer introduced himself as the CSU Extension Office's Food and Agriculture Specialist of the Southern region.

**Attorney's Report**

President Faucette asked for the Attorney's report. Pete Ampe reported on the refilling of the SWAG case and working on various contracts for the purchase of water rights. He updated the Board on the settlement of the Compact litigation TX vs New Mexico/Colorado case. Mr. Ampe highlighted the claims made by Texas and why the Bureau of Reclamation intervened.

**Engineers Report-Clinton Phillips**

President Faucette asked for the Engineers report. Clinton Phillips presented the Alamosa/La Jara monitoring well update. He reported on the change and presented a graph of the composite water head by feet and the current sustainability requirement. Discussion was held on how many years the Subdistrict has remaining to meet the sustainability requirement. They also discussed the CAS stipulations; the matrix and Mr. Phillips presented the pressure head on the wells with data.

**Program Manager Update**

President Faucette asked for the Program Manager update.

- **Financial Report**

Angelo Bellah presented the Financial Report. He highlighted the reimbursements and expenses covered by the District since the formation of the Subdistrict. Mr. Bellah provided the remaining balance and the total remaining expenses paid by and to the District. He highlighted the assets, liabilities and equities from the Balance Sheet and the income, expenses from the Profit and Loss Statement.

A motion was made to approve the financial report as presented. The motion was seconded and unanimously approved.

Angelo Bellah provided an overview of the irrigation season administration. He highlighted the forbearance agreements total acre feet for August, September and October on the Alamosa, Conejos, and Rio Grande rivers. Mr. Bellah reported on the extended irrigation season on the Rio Grande and on the importance of forbearance agreements. He provided an update on the conversations being held with the US Fish and Wildlife regarding forbearance on the Chicago Ditch and reported on the reservoir account balances. The Board discussed and agreed to use the Taos valley water for winter-time depletions. Mr. Bellah provided an update on the Esperanza Farms participation contract and asked the Board for their thoughts on possibly installing a recharge pond. He also updated the Board on the progressing SWSP's.

**Next Meeting**


A special meeting was scheduled for November 20, 2023, at 8:00 a.m.
