# RIO GRANDE WATER CONSERVATION DISTRICT BOARD OF DIRECTORS BUDGET HEARING

December 9, 2020 at 11:00 A.M. By Zoom Teleconference

#### **CALL TO ORDER**

President Greg Higel called the meeting to order at 11:09 a.m. There was a quorum present for the meeting.

#### INTRODUCTION OF STAFF AND GUESTS

President Greg Higel welcomed all those present and asked for introductions.

President Higel asked for amendments or a motion to approve the agenda. Mr. Robbins stated the Board was entering into executive session to receive legal advice concerning Subdistrict No. 1 budget litigation. The Board would take no formal action or position during the executive session.

#### **Action on Executive Session Discussion**

Mr. Robbins stated the Board was in executive session and had voted to come out. Discussion was related to Subdistrict No. 1 budget litigation. President Higel announced for the record no formal action was taken was taken during the executive session.

#### **2021 BUDGET HEARING**

President Higel called the 2021 budget hearing to order and announced the publication notice of hearing information.

#### • Resolution to approve the FY2021 Budget

#### SD#1 Budget Public Comment

President Higel asked for public comments regarding SD #1 Budget. Brad Grassmick introduced himself as the attorney representing North East Well Users Association, he reported on an email outlining objection to Subdistrict No. 1 budget. Mr. Grassmick summarized the objections contained in the email and provided a proposed path forward.

President Higel thanked Mr. Grassmick for his comments.

Peggy Godfrey commented on the Closed Basin Project and the possible connection to Subdistrict No. 1 budget. Director McClure suggested they resume discussions regarding the budget.

#### SD #2 Budget Public Comment

President Higel asked for public comment regarding SD #2 Budget. There were none.

#### SD #3 Budget Public Comment

President Higel asked for public comment regarding SD #3 Budget. There were none.

#### SD #4 Budget Public Comment

President Higel asked for public comment regarding SD #4 Budget. There were none.

#### SD #5 Budget Public Comment

President Higel asked for public comment regarding SD #5 Budget. Director McClure questioned a potential property acquisition, Mr. Simpson explained it would be apart of the District budget.

#### SD #6 Budget Public Comment

President Higel asked for public comment regarding SD #6 Budget. There were none.

#### Rio Grande Water Conservation District Budget Public Comment

President Higel asked for public comment regarding the Rio Grande Water Conservation District Budget. Cleave Simpson reported receiving a recalculation on Tabor and provided the amended levy amount. Director Martin questioned the professional services amount, Mr. Simpson provided an explanation of why the funds were budgeted. Director Off stated the Board of Directors had the opportunity to review Subdistrict No. 1 amended budget prior to today. Director Valdez commended the Subdistrict Program Managers and staff of the Rio Grande Water Conservation District for their time and effort put into developing the most efficient way to use resources while meeting goals. Director Kruse made suggestions on how the Study Funds could be used in the future.

A motion was made by Cory Off to approve the resolution to approve the FY2021 Budget. The motion was seconded by Peggy Godfrey.

Director Kruse responded to Mr. Grassmick's comments and explained why he would vote 'No' on the approval of Subdistrict No. 1 budget. Director Valdez responded to Director Kruse's comments and explained why he would vote in support of the budget resolution.

The motion passed with one vote of no by Mike Kruse.

#### • Resolution to appropriate monies for FY2021

A motion was made by Cory Off to approve the resolution to appropriate monies for FY2021. The motion was seconded by Dwight Martin and unanimously approved.

#### • Resolution to set Mill Levy for 2021

A motion was made by Cory Off to approve the resolution to set Mill Levy for 2021 at 2.35 with a temporary reduction of 0.18 to arrive at 2.17. The motion was seconded by Dwight Martin and unanimously approved.

In 2019 RiGHT developed a new strategic plan with three programmatic goals focused on expanding our conservation efforts to new areas, including groundwater conservation and increasing community engagement. In the conservation realm, we are continuing to conserve land and water along San Luis Valley streams while broadening our work to new areas, especially in Conejos County. We are also developing new tools, based on the conservation easement model, to reduce groundwater use in the Valley. As the Valley's only local land trust, we feel a responsibility to not only conserve land, but also be a good community partner. Through the third goal of our strategic plan, we are expanding our efforts to engage the local community in our conservation work, especially young people. For example

this year, in the face of Covid-19, we initiated a program to support local families in need and local agricultural producers through our Local Farms to Local Families program which provides local youth and families in need with locally sourced foods.

RGWCD funding will assist RiGHT with our land and groundwater conservation work. RiGHT is already working to expand our conservation efforts with fifteen active conservation easement projects split about 50/50 between *Rio Grande Initiative* projects and new geographies. In 2021 we hope to close at least five of these conservation easements, likely with two being fully donated conservation easements. During mid-2020, we finished developing a variety of groundwater conservation tools that are expected to be legally enforceable and have support from potential funders. We are now working with appraisers to understand the possible incentives and values in preparation for introducing the programs to landowners next year in collaboration with Colorado Open Lands. We already have landowners expressing interest and hope to find and implement multiple projects in 2021.

RiGHT's 2021 operating budget for land and groundwater conservation programs is expected to be approximately \$245,000. Headwaters Alliance (HWA) respectfully asks for vital ongoing support from RGWCD to enable the continued work in the Willow Creek Watershed and the Upper Rio Grande Watershed via the Comprehensive Willow Creek Watershed Plan and more.

The Comprehensive Willow Creek Watershed Planning Project is a multi-year, multi-partner project that was initiated in 2020 with generous fiscal support from Colorado Water Conservation Board, Colorado Healthy Rivers Fund, City of Creede, Mineral County, Trout Unlimited and Rio Grande Water Conservation Board (thank you for that!). The objective of the Comprehensive Willow Creek Watershed Planning Project (Watershed Plan) is to effectively collaborate with partners and stakeholders to establish a *Willow Creek Watershed Plan* that meets established criteria, as well as to facilitate the implementation of cohesive and integrated projects that lead to improved water quality, stable riparian zone, ecologically functioning floodplain, healthy fisheries, flood mitigation and thoughtful recreational design in the face of climate uncertainty and the very real and pressing need to improve water quality and maintain water supply.

#### Headwaters Alliance is seeking RGWCD funds to support the following in 2021:

- 1. 2021 Comprehensive Willow Creek Watershed Planning Project focus includes:
  - a. *High-level analysis and modeling of the newly completed, integrated Willow Creek Watershed Database*. The database (estimated completion date December 2020) will include 20 plus years of surface and ground water, and soil quality data collected by the eminent Willow Creek Reclamation Committee, EPA, CDPHE, USGS, DRMS and others into a single integrated database. The analysis work will be completed by a diverse team of experts, led by Dr. Kathy James, PhD, Environmental Health, CU Anschutz Medical Campus. It is worth noting that this level of analysis has never been done before on this data set.

- b. Stream gage on the main-stem of Willow Creek, below the Nelson/Commodore Waste Rock Superfund Site and above Windy Gulch. We are working to update and make the old USGS stream gage on Willow Creek operational. This gage will provide key info to inform our community's commitment to see a final remedy for water treatment at the Nelson Site, to aid in emergency response in the North Creede reach during high water events and quantify water contributions to the Rio Grande from Willow Creek and more.
- c. Ongoing water quality sampling of Willow Creek. HWA is currently sampling 4 sites on Willow Creek, ranging from the most upper watershed to the Rio Grande, as well as 4 sites on the Rio Grande from above Willow Creek to LaGarita Bridge. While all sites are being tested through CPW's River Watch program, four sites will be tested via split sampling procedures with ACZ Labs to ensure rigor and validity, as well to inform the current Temporary Modification for RG4A with the Colorado Water Quality Control Division. We have also initiated macro-invertebrate sampling to further inform the possibility of optimal sites for fisheries within the watershed, for water quality attenuation downstream of Nelson Site and an eventual remedy for water quality.
- d. Release Request for Proposal for Stream Stability and Flood Control of North Creede reach of Willow Creek (from flume to confluence of East and West Willow Creeks). This reach is especially vulnerable to upstream impacts, conveyance of large material and sediment with no bank stability or vegetation. Environmental design will seek to bring much needed engineering to mitigating the impacts from these risks. The cost for the design itself has been entirely funded by CWCB and City of Creede, RGWCD funds will support HWA administrative efforts of facilitating expert work groups to create a thoroughly vetted and comprehensive RFP. Additionally, HWA has already successfully worked with CWCB and City of Creede to submit paperwork to FEMA to certify the levee. This work will also inform the in-process, new Rio Grande floodplain mapping being completed by Wood PLC.
- e. Ongoing leadership by HWA and community facilitation in regards to the Nelson/Commodore Waste Rock Superfund Site. Yes, this is long-standing work. Our involvement both within Mineral County and downstream will be required until there is a final remedy for water quality treatment to reduce the high levels of contaminants entering Willow Creek and the Rio Grande. We have worked hard in the past year to establish a stronger working relationship with our EPA Project Team. We will continue to host community meetings, ask challenging questions and seek creative yet practical solutions that serve our community and the River itself. This is particularly relevant as the EPA has recently opened two public comment periods in reference to potential funding for work and a focused feasibility study for a flow-through bulkhead (all links below with photos.)
- 2. New Projects informed and inspired by the Comprehensive Willow Creek Watershed Planning Project. A key component of thinking comprehensively has been asking how does our work support the very real and pressing goals for water quantity and water quality for the Upper Rio Grande and the San Luis Valley, both within Willow Creek Watershed and for the pristine Rio Grande as it flows through Mineral County. As such we will be addressing the following two projects in 2021:
  - a. Upper Rio Grande Tributary Stream Gage Project, a new project to be included within the updated Rio Grande Basin Implementation Plan. The goal of this project is to increase the understanding of the water contribution of key tributaries in Mineral County into the Rio Grande by collecting stream flow data from the many tributaries, especially during snow melt and other high-water events, in the Upper Rio Grande Watershed to include both the main-stem and South Fork of Rio Grande. This project will both supplement and draw guidance from the 2015 Upper Rio Grande Basin Snowfall Measurement and Streamflow (RIO-SNOW-FLOW) Forecasting Improvement Project, prepared for Colorado Water Conservation Board and Conejos Conservancy District. We are currently working with a team of experts to better refine the scope of this project, to be implemented in Spring 2021.

b. Mineral County consumptive and non-consumptive water use assessment, a new project to be considered for inclusion within the updated Rio Grande Basin Implementation Plan. The intent of this project is to better quantify water use and inform future land and water development practices in the Mineral County. Building on existing reference resources, i.e. CWCB's 2019 Technical Update to the Water Plan, Rio Grande Stream Management Plan, etc., we will seek further project funding to better quantify and understand water quantity and use within Mineral County as central to supporting the goals of the Rio Grande Basin, the RGWCD, land and water use planning in Mineral County and our collective grandchildren's future.

#### Funding from RGWCD enables us to achieve the above by:

- a. Operationalizing project implementation. Indeed, what HWA needs most, what we suspect many of the small-yet-mighty non-profits doing important work in the SLV need most, are funds to support administrative efforts and general operations. We are in the fortunate position that while nearly 90% of above mentioned project-specific costs have been provided for by CWCB and others, HWA remains vulnerable to maintaining our basic operational expenses. As an organization both as HWA and as our legacy predecessor Willow Creek Reclamation Committee we have always worked hard to keep organizational expenses as low as possible. Funds from RGWCD ensures that our local staff of one plus a(n exceptional) AmeriCorps VISTA volunteer can achieve this long list of measurable; which is only 28% of our total 2021 projected budget. Sincerely and simply, funds from RGWCD make it work.
- b. The community value of the RGWCD funds. Last year's support from RGWCD served as the seed money that provided the first-money-in to meet the requisite match funds necessary for CWCB. And in doing so, affirmed the value of the project; and increased contribution by both the City of Creede and Mineral County in supporting a comprehensive approach to addressing the many tangled complexities of Willow Creek.
- c. The leverage value of RGWCD funds. HWA sincerely thanks RGWCD for funds received in 2020. As noted above, these funds leveraged a dollar to dollar to match from CWCB, so RGWCD's contribution of \$20K realized \$40K worth of funding for vital work within Mineral County. Additionally, RGWCD's contribution in 2020 funds elevated contributions from other entities. We will again be utilizing RGWCD's contribution to match for other funds. This is hugely significant to an organization of our size in a rural community of our size where every single dollar means survival.

Investment in Mineral County as a vitally critical ecological region and civic community in the long-term health of the Rio Grande. While Mineral County may not be the biggest water-user within the Rio Grande system, our beloved San Juan Mountains attract, collect and hold the snow that feeds the Upper Rio Grande. HWA, as the legacy organization of the Willow Creek Reclamation Committee, is the sole organization within Mineral County attending to this work or way of thinking. With this said, we acknowledge that the needs of the Upper Rio Grande in Colorado are pressing and real given the current drought conditions and threats of climate variation and unpredictability. We sincerely seek to be partners with RGWCD, to do our part in due diligence to understand environmental water quantity and quality within the county, to conserve wherever possible, to improve water quality, to create a sustainable future for our grandchildren.




# North Creede Project Elements and Locations



North Creede Reach. This is a complex ½ mile. While austerely beautiful in its barrenness wrought from legacy mining impacts, this reach will benefit will from the expert engineering eye that brings stream stability, vegetation, reduces and /or mitigates the downstream conveyance of large material and reinforces antiquated structures last tended in the 1950's.



Water Quality Sampling. This is a key activity that requires rigor in process to maintain validity and fortunately, a favorite for volunteer participation.



Lower Willow Creek Floodplain Design: While no RGWCD funds have been used to obtain a new design for the Lower Willow Creek Floodplain, we want to share that 12 organizations attended the pre-bid site tour and we are expecting at least 5 – 6 bids, due October 22, 2020. What makes this process different from the first attempt is (1) that we are seeking a design for the entire reach – flume to Rio Grande, across property lines, with the support of all 5 property owners; (2) design criteria prioritizes ecological function first and foremost; (3) we have solicited bids from diverse, top-tier environmentally solid companies across the Western region. We will be reviewing applicants in late October for selection in November 2020.

Implementation of final design will have beneficial impacts to the Rio Grande.

CODOS is an applied science monitoring and research program designed to assist the Colorado water management community in coping with the impacts of dust-on-snow on snowmelt behaviors. CODOS monitors and samples dust-on-snow events in the San Juan Mountains and in most major Colorado headwaters. CODOS publishes a series of Update and Alert products describing current and evolving conditions throughout the winter and spring of each season. Using a "Dust Enhanced Runoff Classification" (DERC) methodology, CODOS associates those evolving snowpack, dust, and spring precipitation conditions with past-year hydrographs, by watershed, to identify plausible patterns in the current year's snowmelt runoff hydrographs.
